

**Phantom Manufacturing (Int'l.) Ltd.
"25 Year Anniversary" Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The following Sweepstakes is intended for legal residents of the United States of America and Canada only and shall only be construed and evaluated according to U.S. & Canadian law. Do not enter this Sweepstakes if you are not located in the United States of America or Canada at the time of entry.

ELIGIBILITY: The "25 Year Anniversary" Sweepstakes (the "Sweepstakes") is open and offered only to legal residents of the 50 United States (including the District of Columbia) or Canada (excluding the Quebec province), who have the age of majority in their state/province of residence or older at the time of entry ("Entrants"). Employees of the Sponsor and the Administrator (both defined below), their immediate families (parent, child, sibling or spouse) and/or household members and any other persons or entities associated with this promotion are ineligible to enter or win. Void outside of the United States, Canada, in Quebec, and where prohibited by law.

There are two (2) ways to enter the Sweepstakes during the Sweepstakes Period:

Released Parties (as defined below) are not responsible for: lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due mailed entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. By participating, you consent for Sponsor to obtain, use, and transfer your name, address and other information for the purpose of administering this Sweepstakes and for other purposes as set forth below. All information submitted by Entrants will be treated according to Sponsor's privacy policy, available at <http://www.phantomcreens.com/privacy/>. By participating in the Sweepstakes and providing any personal information, Entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Policy.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (a) infection by computer virus, bugs, (b) tampering, unauthorized intervention, (c) fraud, (d) technical failures, or (e) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the applicable Prizes using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the

spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor's Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials in this Sweepstakes. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

DRAWING AND NOTIFICATION: The potential Prize Winners will be selected in twenty-five (25) Weekly random drawings from among all eligible entries received in a given Week. ***NOTE: Entries are only eligible for the Prize drawing associated with their Week of entry. Entries will not roll over and be eligible in subsequent Weekly drawings.*** All Prize drawings will be conducted by the Administrator, whose decisions are final and binding. Each Prize drawing will be conducted on or about the Tuesday following each Week. One (1) Winner will be selected each Week (25 total Winners). The potential Prize Winners will each be contacted by the Administrator via phone, email and/or by USPS mail. Limit one (1) Prize per person per household.

PRIZES & PRIZE CONDITIONS: There will be **twenty-five (25) Prizes** awarded. Each Prize Winner, upon the Administrator's confirmation of eligibility, will receive a \$500 cash award (US/Canadian currency depending on the Winner's country of residence). Total Prize Pool - \$12,500.

By accepting a Prize, the Prize Winners agree to release and hold harmless the Released Parties, each of their related companies, and each of their respective officers, directors, employees, shareholders, and agents from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of the Prize in question.
